Finance Committee

Background and Statement of Purpose as developed in 2022

Background

The Town's Finance Committee (FC) consists of two Town Board members, the Town Bookkeeper and the Town Budget Officer.

The FC was established at the beginning of 2022 to support the financial operations of the Town and facilitate communications between Town Hall staff and the Town Board regarding financial matters. The FC will meet at least once a month to review and provide input on financial matters. Town Board members on the FC will report back to the Town Board as a whole during regular Town Board meetings.

Statement of Purpose

The primary purpose of the FC is to support Town staff who oversee the financial operations of the Town and plan for the long-term financial stability of the Town. The FC assists with financial planning, and the development of financial procedures and policies. The FC reviews financial reports and analyses and makes recommendations through collaborative team work to ensure quality outcomes.
