MINIMUM QUALIFICATIONS:

(a) Graduation from High School or possession of a High School equivalency diploma

(b) Possession of Current "D" certification

SPECIAL REQUIREMENTS:

The successful candidate will possess a current Grade D water certification issued under the provisions of the New York State Sanitary Code at the time of application.

The successful candidate will possess a valid NYS Drivers License Class D at the time of application and maintain such license throughout the duration of employment

DISTINGUISHING FEATURES OF THE CLASS:

A Water Distribution and System Supervisor is responsible for the maintenance and operation of, and connections to the town water distribution system serving 1000 or fewer people or units of water purchased. The primary responsibility is to ensure the continued distribution of potable water to the customers. This is a technical position involving responsibility for the safe and efficient operation and maintenance of the Town of Ulysses water distribution system, including application of chemicals to water, such as chlorine or chlorine compounds, chlorine dioxide, chlorine ammonia, fluoride compounds, or the processes of dechlorination under the supervision of Bolton Point Municipal Water System. The WDSS performs or oversees the installation, maintenance, and repair of water mains, valves, and hydrants as is spelled out in Attachment A of the contract with Bolton Point (attached). General direction is received from the Ulysses Town Board, but wide leeway is allowed for planning work methods and dealing with emergency conditions. The WDSS reports to the Town Supervisor, who will distribute updates to the Town Board. The Water Distribution and Maintenance Operator will supervise additional staff or contractors as necessary. The incumbent will perform all related duties as required.

TYPICAL WORK ACTIVITIES:

- Responsible for the operation of the Ulysses water districts commencing at the Town line.
- Performs daily checks at the pump house (Woolf Lane) to record meter reading and tank status.
- Performs daily Chlorine Residual tests, at least one location (usually more), seven days per week, 365 days per year.
- Perform all additional tests as required by DOH in coordination with Bolton Point.
- Obtains annual copper and lead samples from 10 houses built prior to 1984.
- Collects monthly microbial samples as required by DOH.
- Inspects all new line installations and meter hookups, including preparation of Corp. Stop maps

- Works with Bolton Point to conduct backflow prevention surveys to ensure that DOH standards are met.
- Performs quarterly meter readings. Calculates total water usages for the Town of Ulysses and presents it to the Town of Ithaca to reconcile the difference in meter readings due to leakage within the system according to the water service agreement with the Town of Ithaca.
- Responsible for contractor registration and certification. Ensures that the system is repaired, either by Ulysses or Bolton Point staff, or under the Intermunicipal Agreement with the Village of Trumansburg or the Town of Ithaca.
- Maintains and records all DOH required records.
- Prepares and submits all reports required by the Tompkins County Department of Health.
- Maintains a minimum type "D" Certified Water System Operator license, (Type "C" is preferable) in accordance with NYS Sanitary Code Subpart 5-4.

- Performs valve, corporation stop, and fire hydrant maintenance as required.
- Provides "Dig Safe New York" locations as requested.
- Is responsible for or makes provisions for coverage 24 hours per day, 7 days per week, and 365 days per year.
- Responds to other distribution related emergencies as directed by other agencies.
- Notifies users of emergency procedures as necessary. • Answers service distribution related questions and provides permit application approval.
- Maintains and operates the chlorination pumps at the tank.
- Addresses user's questions or complaints.
- Performs all other maintenance and operation as needed for the system to operate properly.
- Generates quarterly reports, including problems, corrective action, expenditures, meter readings and billing summary

KNOWLEDGE, SKILLS, ABILITIES AND PERSONAL CHARACTERISTICS:

- Thorough knowledge of the practices used and equipment required in the operation and maintenance of a Town water distribution system;
- Thorough knowledge regarding application of chemicals to the water such as chlorine, chlorine compounds, chlorine dioxide, chlorine ammonia, fluoride compounds, or the processes of
- dechlorination although chlorination duties may be delegated to Bolton Point licensed operators; Good knowledge of the tools, equipment and terminology used in water distribution systems and in the construction and maintenance of those systems;
- Good knowledge of the principles of hydraulics as related to Grade "D" water distribution system in accordance with NYS Sanitary code subpart 5-4. A C license is desirable but not required if working under the supervision of Bolton Point operators
- Good knowledge of the principles of physics, chemistry and bacteriology;
- Ability to read plans and draft sketches to interpret plans and specifications;
- Has the ability to carry out directions;
- Has the ability to plan and oversee the work of any contract activity or subordinates;
- Possesses a mechanical aptitude;
- Dependability and good physical condition are required.
